Windfarm funding	The Committee will continue to seek funds from other sources for rewiring, insulation and heating to complement the funds secured to reroof the Hall. The feedback on the other two bids was noted and actions agreed: • repairs to Auchgoyle Burn Bridge on the circuit to improve safety and ease access • immediate repairs at certain locations on the Brainport Trail plus development of plan for future works	All

	We need to confirm details of ownership of the Auchgoyle Bridge and land either side. No progress on the previous action (Liz to check with John Goodwin (who built the original bridge) and Margaret to check with Estates at the Council). Agreed that Margaret to raise at the next Community Council meeting (31 July) and ask if they are able to get details of land ownership (from own records? Or a request to the Council).	Margaret
	Liz has details of costs of path counters for the bridge from contacts provided by John and Karen Taylor. The Trust is unable to afford this at present, but could include in the costings for the next bid for the bridge. In terms of timing for the next bid, the survey will provide more meaningful data.	
	Conduct another survey on the path network (in the village and at Brainport and Crarae) to gather more evidence of support for the path improvements. Liz to draft questions, Brian to check how they can be included in the Trust web site. Still being progressed.	Liz/Brian
